

PARTY BOOKING CONTRACT

PARTY TIMES & BOOKING DETAILS

- All parties are a total of 2 ½ hours in length, include full access to the playground for your party guests, and a private party room for the duration of the party time
- Party time frames and dining times are as follows:
 - o **11:30am 2:00pm,** suggested party dining time 12:30am
 - **4:30pm 7:00pm**, suggested party dining time 5:30pm
- We strongly encourage adhering to the suggested party dining times to help keep your party timely and for the most enjoyable experience for you and your guests
- <u>This is a non-hosted party</u>. The booking host is responsible for their own room set-up, break down, and clean up. However, an attendant will be assigned to assist with guest check-in and requests as needed
- Booking host will be allowed access to the party room <u>1 hour prior</u> to their party start time for decorating and set-up. This allows staff proper time for room clean-up and turnover between parties

PARTY COSTS & CHARGES

- Available Party Options:
 - OPTION #1 NON-PRIVATE PARTY, UP TO A MAX. OF (30) GUESTS TOTAL \$499
 - OPTION #2 NON-PRIVATE PARTY, UP TO A MAX. OF (50) G UESTS TOTAL \$699
 - OPTION #3 PRIVATE PARTY (FACILITY BOOKOUT), UP TO A MAX. OF (75) GUESTS \$1,499
- The birthday child <u>is included</u> in your guest total
- Children under 12 months of age are free and will not count toward your total guest count
- The booking of the party is **ONLY** absolute upon receipt of deposit and return of signed contract
- The party deposit is applied towards the total party option price
- The party deposit <u>is refundable</u> or <u>transferable to another date</u> ONLY IF notification for cancellation or rescheduling is made to the Party Manager at least (3) three weeks prior to your booked party date.
 ABSOLUTELY NO <u>refunds</u> or <u>rescheduling of dates</u> will be made if cancellation is within or less than (3) three weeks of your party date
- An extra 30 minutes of playtime can be added to the length of your party for an additional fee. The additional time will be for playtime ONLY, and does not extend your time in the party room
- **Excessive Dirty Fee:** A fee of \$75 will be charged if the room is left completely soiled or if there's any damage to walls or furnishings (this determination is at the sole discretion of Romp-o-Rama)
- Late Fee: A fee of \$50 will be charged if guests stay past party end time by more than the 15-minute grace period



PARTY PROCESS, PAYMENTS & PLAYGROUND REGULATIONS

- A Party/Event Manager will contact you the week of your booked date to confirm all details of your party, including final guest count and any add-on services
- The final guest count, any add-on orders, extra playtime add-on, or party package upgrades/downgrades are <u>due no less than 5 days prior to your party date</u> and your final invoice will reflect this total. <u>IF your</u> guest count exceeds the total count of your confirmed Party Option, you will be upgraded to the next level Party Option and charged the difference in price OR unaccounted for guests can be turned away
- Outside food and drinks are permitted at no additional fee, but must be kept in the party room
- Payment of final balance is due the day of your party, *upon arrival. A credit card will need to be kept on file at the time of deposit payment to resolve any outstanding balances*
- A Liability Waiver must be signed for <u>every</u> person entering the facility by going to
 <u>www.romporama.net</u>. A waiver for each child under the age of 18 years old MUST be signed by the
 <u>PARENT</u> or <u>LEGAL GUARDIAN</u>, no exceptions. Up to 2 additional adults and up to 6 children can be
 added to a waiver form in addition to the primary adult
- The party host is responsible for all guests following all playground rules, safety regulations, and proper
 use of the equipment. <u>It is your responsibility to ensure all guests are familiar with and comply with
 all playground and safety regulations, sock policy (which applies to everyone, including adults), and
 that every person completes the online waiver or is on a family waiver. Romp-o-Rama reserves the
 right to ask any quest to leave the premises that refuses to comply with any regulation
 </u>
- NO CASH is kept on premises. Only credit card or mobile app payments are accepted in our playground
- ABSOLUTELY NO ALCOHOL OR DRUG USE on premises or surrounding perimeter
- ABSOLUTELY NO SHOES or BARE FEET past reception area (applies to EVERYONE, including adults)
- ABSOLUTELY NO FOOD or DRINK allowed on play structures or main floor playground area. All food set-ups and consumption are limited to party room only
- ABSOLUTELY NO Piñatas, NO confetti, NO open flames, NO glassware/breakables, NO hanging anything from ceilings and NO tacks, staples or punctures are allowed in walls for hanging any décor.
- Any goodie bags and balloons MUST be handed out at departure ONLY, not before
